- Geolocation information, such as your country and city.
- Social media information, such as your social media handle, when you use our social media plug in features, engage with us on social media platforms or tag us in your posts.
- Preferences and profiles, including your favorite brands and the pattern of your transactions.
- Other information that you may share in chat rooms or messages.

- Children’s information under certain circumstances. We may collect information from children younger than 18 after we have obtained verifiable parental consent, as explained in policies at <https://toekenz.com>.

How We Use Your Personal Information

We may use your personal information for the following business purposes:
